**Opening of the Meeting:**

Chairperson Earl Smith called the San Bernardino County Juvenile Justice and Delinquency Prevention Commission meeting to order at 3:30 p.m.

**Flag Salute**

First Vice Chairperson Joyce Frevert led the commission in the Pledge of Allegiance.

**Roll Call**

Secretary Diana Martin conducted roll call.

**Absent:** Dwayne Radden Sr.

**Approval of Minutes**

Motion to approve the January 10, 2018, minutes was made by First Vice Chairperson Joyce Frevert, seconded by Commissioner Edward Brantley, and passed unanimously.

**Judge's Remarks**

**Honorable Annemarie G. Pace**

- The Governor's new budget is favorable and the courts will be returned funding that was previously lost
- Supervising judges met with Assemblyman Obernolte regarding the increases to the budget and their effect on the court. Assemblyman Obernolte is proposing a bill that would allow for ten more judges statewide, with the hope that a few would be placed in San Bernardino County

**Chief's Remarks**

**Chief Probation Officer or Designee: Deputy Chief Probation Officer Kimberly Epps**

- The BSCC has finalized and approved the Juvenile Title 15 and Title 24 regulation revisions
  - There was a discussion about banning OC spray, but it was not approved
  - Current staffing ratios were maintained. The vote was 8-3 in favor of Option 1, which is to maintain awake hour staffing ratios of 1:10 in the halls, 1:15 in camps and asleep hour staffing ratio of 1:30
- 2017 legislations signed into law
  - SB 190 - Eliminates juvenile fees for detention, attorneys, electronic monitoring and drug testing
  - AB 395 - Requires that youth, 15 years of age or younger, consult w/counsel prior to a custodial interrogation and before waiving any specified right

- AB 766 - A minor who is at least 16 years old, may receive AFDC-FC payments directly if they are:
  - Enrolled in college
  - Living independently in a dorm or other designated housing of the institution
  - Placement is made pursuant to a supervised placement agreement
- AB 878 - Limits the use of restraints to transport a minor from a juvenile detention facility and clarifies when restraints may be used in juvenile court
- Legislation introduced
  - AB 2010 - Introduced February 1, 2018, by California Assemblyman Ed Chau (D). This bill proposed to prohibit employees of juvenile facilities from carrying pepper spray on their person(s) within the facility

### **Coordinator's Remarks**

#### **Probation Officer III Yaquelin Galvan**

- All mileage forms must total at least \$25 before they are submitted
- The JJDPDC brochure and flyer are completed and are being distributed
- Applicant Chanda Kellogg is still in the background process
- The JJDPDC commercial/recruitment videos are in process. The Teen Dating Violence Awareness video was filmed today and will be posted on social media as soon as it is completed
- Requested commissioners to assist with a recruitment booth at the San Bernardino County Probation Department's Volunteer Training Social, which will be held on April 20<sup>th</sup>

### **Chairperson's Remarks**

#### **Chairperson Earl Smith**

- The executive committee would like information about Probation sponsoring a CPPCA membership for the commission. The committee would also like to know how many commissioners can attend the CPPCA conference this year. Coordinator Galvan will gather the information and update the commission
- Riverside County is holding their JJDPDC Awards ceremony on March 6<sup>th</sup>, and it was suggested that commissioners attend to show their support

### **Old Business**

- DCPO Epps asked where the commission stands regarding the teacher's award event. Coordinator Galvan stated that the executive committee is to complete the criteria for the awards and per the commission, the first ceremony should be in 2019

### **New Business**

- Second Vice Chairperson Dr. Frances Coles asked for an update on the list of inspections from the Board of State and Community Corrections. Coordinator Galvan stated she has not received the list, but will update the commission as soon as it is received
- Coordinator Galvan will hold a Prison Rape Elimination Act (PREA) training at the March meeting in order to keep the commission in compliance

**Roundtable****Secretary Diana Martin**

- A teen dating/healthy relationship workshop was held at Sequoia Middle School. Advised if anyone was in need of more information regarding the workshop to contact her

**Commissioner Edward Brantley**

- Would like to create a summer job training program for at-risk youth. Coordinator Galvan will send his information to the Juvenile Detention and Assessment Center superintendents and the Youth Justice Center supervisors to see if they can use his services/programs

**Commissioner John David Reitzel**

- Would like to get students involved in volunteering and would like to get them information about the Volunteers In Probation (VIP) program. Coordinator Galvan will provide him with any necessary information.
