#### **REQUESTED DOCUMENTS**

#### 1) <u>Current / ENTIRE copy of utility bills</u>: GAS <u>AND</u> ELECTRIC

- BILLS MUST BE COMPLETE (No assistance can be provided without the actual utility bills showing usage)
- ▶ BILLS MUST BE FOR A MINIMUM OF 22 DAYS OF SERVICE
- FINAL CALL OR SHUT OFF NOTICE is necessary, but <u>DO NOT</u> take the place of the actual Gas and Electric bills.
- Rental agreement or mortgage payment book for CURRENT address showing your name and proof of residency. <u>NO RENT RECEIPTS</u>

#### 2) Acceptable types of IDENTIFICATION:

- CALIFORNIA PICTURE ID with CURRENT address a <u>MUST</u>.
  No brown above of address conde from the DMV accented
- No brown change of address cards from the DMV accepted.
- SOCIAL SECURITY CARD A <u>MUST.</u>

#### 3) <u>CURRENT proof of income</u>:

- > TANF (AFDC), <u>FOOD STAMPS</u>, General Relief for the CURRENT MONTH
- 2012 Award letter for SSI/SSA or <u>CURRENT</u> bank statement showing amount (s) deposited. NO 1099 forms for the year 2011 SSA/SSI income.
- ▶ WAGES (check stubs for prior 30 day PAY PERIODS).
- Need verification of income for all adults 18 yrs and older in the household. (If he/she does not have income, a CSD 43B Survey of No Income must be completed by each adult member).
- > Income contributions/cash payments should include date, name, address of person giving contributions.

#### 4) CHILD/SPOUSE/INDIVIDUAL SUPPORT

CURRENT MONTH print out of prior 30 days monies issued from the District Attorney's office or SELF-CERTIFIED signed and dated statement from person providing support. Including his/her address and telephone number.

#### CLIENTS ARE SEEN ON A FIRST COME FIRST SERVE BASIS

PLEASE NOTE: In 2012, besides meeting income guidelines, applicants must meet set energy burden levels and required points as outlined in our Priority Plan. The Priority Plan is designed as a guide so that we may serve the "neediest of the needy".
