# HEAP ASSISTANCE FOR 2012 WOOD/OIL/PROPANE

To qualify for this program, Wood <u>MUST BE</u> your <u>MAIN</u> source of heating or you must live in rural areas of the County with propane as your <u>main source of heating</u>. If you have natural gas, <u>you are not eligible</u> for this program. However, families in the Mountain Communities are EXEMPT due to extreme weather conditions and high fuel bills.

Eligible households are assisted once every year. Maximum amount is \$350 for a cord of wood or up to \$600 for propane. Clients are responsible for charges in excess of this amount. Services are delivered after payment is received by the utility/wood company. This amount does not include propane tank rental charges, taxes.

## 1) An Estimated statement must be on letterhead from the wood or propane company and must include:

- Applicants name, address, city, zip code and also mailing address if applicable.
- ➤ Account number
- > Price of wood (cord) or propane per gallon.
- Number of months a cord of wood or propane fills will last (at time of applying)

## 2) DOCUMENTATION REQUIRED: (COPIES ONLY)

- ➤ Both **CURRENT GAS** and **ELECTRIC** bills with <u>usage</u> are required (all pages to electric bill). (Note: Bills must be for a minimum of 22+ days of service.)
- Rental agreement A <u>MUST</u> for CURRENT address /mortgage payment book showing your name and proof of residency. NO RENT RECEIPTS
- 3) ACCEPTABLE IDENTIFICATION:
- > CALIFORNIA PICTURE ID with CURRENT address a **MUST** 
  - No brown change of address cards from the DMV, only current printouts from the DMV will be accepted showing current address.
- ➤ SOCIAL SECURITY CARDS A MUST for all Household Members
- 4) **CURRENT proof of income:**
- ➤ Proof of AFDC (TANF), **FOOD STAMPS**, General Relief for CURRENT month
- ➤ Proof of SSI/SSA MONTHLY benefits for 2012. NO 1099 forms for the year 2011 SSI/SSA payments.
- ➤ WAGES-Pay stubs for all PRIOR 30-DAY pay periods.
- ➤ Verification of child support ("CURRENT MONTH" printout of prior 30 days monies issued) from the district attorney's office
- For state disability, worker's compensation, unemployment benefits or pension, you must show all pay stubs for all pay periods for the prior 30 days.
- ➤ Need verification of income for other adults in household. (If he/she does not have income, a CA43B Declaration of No Income must be completed by each adult member). Income contributions/cash payments should include date, name, address of person giving contributions.

#### HEAP APPLICATIONS FOR WOOD/OIL/PROPANE ARE PROCESSED BY MAIL ONLY.

<u>PLEASE NOTE:</u> In 2012, besides meeting income guidelines, applicants must meet set energy burden levels and required points as outlined in our Priority Plan. The Priority Plan is designed as a guide so that we may serve the neediest of the needy
