Educational / Vocational Needs

- Youth will be in program over a significant length of time; allowing for high school to college/vocational pathways
- Pathway will be dependent on resources available, funding and youth interest
 - Pathway can be created to include hard and soft skills that can be transferable to any program/employment ; build upon portfolio
- Two Tracks for youth
- Youth without high school diploma
 - County Schools has capability of providing services
- Youth with high school diploma develop Secondary Education or Vocational Training
 - o Utilize data regarding needs of San Bernardino County Employers / Labor Market
 - **ROP programming ideas**
 - Hard and Soft Skills
 - Computer Coding

- Microsoft Office Skills
- Cyber Security
- Automotive
- Maintenance
- HVAC
- Fork Lift
- Culinary (high overhead cost)
- Some programming would require labs and/or work spaces
- o Determine what classes can be taught virtually and in-person
- Teachers would need to be given incentives to leave industry to teach; dependent on how often they are needed and type of position
- Secondary Education
 - College Pathway courses
 - Partnership with local Community Colleges
 - 9 youth currently enrolled with Mission College in Los Angeles
 - County Schools work with Pathway Coordinator Liaisons
 - Determine 4 year degree courses
 - Cal State SB has logistic and automation programs that can be utilized
 - Cal State SB has a Reentry program

• Infrastructure / Technology

- HDJDAC is equipped with three access points to cover areas youth may be working in
- o 125 MB wireless link has been installed
- Possible devices include Chromebooks (Google based) and Dell laptops (Windows OS)
 - Windows OS requires more maintenance for updates
 - Security and Restrictions will need to be implemented on devices; Chromebooks utilize the Go Guardian app
- Include cognitive life skills / readiness skills / parenting classes
 - o Young Visionaries
 - CFS curriculum

Mental Health Needs

• Proposal in works with DBH; more follow up at next meeting

Additional Topics of Discussion

- Ideas on how to engage this population
- Determine the needs for pathways; funding and resources available; guiding towards lucrative careers
- Determine one to two pathways to build upon
- Assessments of youth can be built into pathways; determine interests

Follow-Up Items from Previous Meeting

• Youth with CFS History - out of 133 youth committed to DJJ

JJCC Executive Subcommittee Minutes

- # of youth with CFS history = 21 (15%)
- \circ # of youth with children of their own with CFS history = 10 (7.5%)
- Although numbers are low; connection between parent and child should be built into program
- Gateway program provided IPads for nightly use for youth to connect with children, read books
- Will need to work with providers, foster parents and group homes to allow connections to occur
- County Fire Program awaiting to receive outline
- Workforce Development and Urban Conservation Core ready to be involved; dependent on funding
- Court / DA / PD Workgroup continue to work together
 - Reviewed language on commitment orders
 - Review of mandatory Court forms; unknown what changes will be made statewide

Follow Up Items

- E. Raley to meet with County School staff to determine potential providers
- C. Garofalo to update group once more information is available regarding Juvenile Advisory Council "Best Practices" guide
- Continue to include partners with development needs
