# **Opening of the Meeting:**

#### **New Business**

SB 823 Juvenile Justice Realignment Plan – DRAFT: Discussion

#### Part 2: Target Population

- Female Population not addressed up front; no specification of working with other counties to house
  - o At this time, it is still being determined which county will house females
  - Per Chief Reece, CPOC is working to address funding for counties supporting specialized programming as well as group type counseling
- Last check 48 youth at DJJ, 13 at Hall waiting for transport and approximately 45 out on Community Supervision; anticipate these are the starting numbers for local program
- DJJ is viewed as a last resort for juveniles

#### Part 3: Programs and Services

- Multiple step-down and phased approach
  - o Phase One: HDJDAC will be used as the Secured Youth Treatment Facility (SYTF)
  - Phase Two: After 6 month review, and every 6 months thereafter, Court may make order to move youth from SYTF to former Gateway facility; community access with return to facility in evenings

- Phase Three: Placement, Community-Based Organizations (CBO) and other housing options; full community access
  - How will this work? What services will be mandated? Probation, along with CBO, will continue treatment plan such as substance abuse and mental health
  - CBO members will be assigned as mentors and be able to assist with housing and transportation
- o Court can make ruling to send youth back to SYTF for major violations
- Focus on strength and needs assessment, rather than risk
- Individual Treatment Plans preparation from onset for release to community
- Treatment and Peer Interaction
- What would treatment entail? Per Carpenter assessment, planning and treatment to begin at HDJDAC and continue through to Gateway to A.R.I.S.E.
- Classification Due to Title 15 requirements, risk assessment will still be made; multiple units at HDJDAC to move youth around; classification can change over time

#### Part 4: Juvenile Justice Realignment Block Grant Funds

- Funding will be based on population and is expected to increase yearly; Full closure of DJJ in June 2023 will allocate State funds to local level
  - o County will receive funds; committee will make recommendations as to allocations
- Request for Information
  - o Closes April 20th at 5:00 pm
  - List of proposals will be sent to committee members for review; abstain from voting for your own program
  - Committee to determine which programs can be put into place for July; request RFP once cost breakdown is received, contracts can be created; adjust as needed
  - o Committee will keep list of multiple providers to serve needs/areas
  - o Committee will make recommendations on amounts to award vendors

  - Nothing additional than what is currently received at this time

# Additional Topics of Discussion:

- Training for Staff
  - Probation staff will begin program training on May 24<sup>th</sup> to begin preparation and team building; 180 hours of onboarding
  - o Additional training hours to include LGBTQ needs
  - Will Probation Officers will be trained on how to write reports? Yes, once program is approved training can begin
- Policy Handbook Orientation handbook will be created once treatment plans have been finalized;
   will address incentive for levels

- Use of Cognitive Workbook to engage youth, family and trusted adults to discuss plans and goals
- Clean-Up Language Court review every 6 months with a Probation and DBH reports; Court will decide disposition based on programs and commitment
  - Completion of individual youth treatment plans would determine type of report given to Court
  - o In-person Court appearances are more beneficial to youth; 75-80% increase rate
  - Video Court is also an option
- Community Outreach as program is developed, can attend community events to discuss program; develop pamphlets and flyers for distribution

# Timeline

Previously, program was to be presented to Board of Supervisors in March/April; goal is to present 75% of plan to BOS by June

- Plan is due to State by May 2022
- Plan is to be updated/revised yearly and resubmitted to State

Sandra Bonilla

- Her program worked closely with Gateway Once in Phase 2 and 3, will Probation continue to drop off youth or will they need to provide own transportation? Both. Probation, CBOs and youth will provide transportation
- Possible wording changes from the rapeutic approach to positive youth development
- Providers not always interested in funding, but to assist community and youth
