Approval of Minutes

Old Business

SB 823 Juvenile Justice Realignment Plan – DRAFT rev. 14 – Discussion

Part 2: Target Population

Include sentence that states sex offenders, females and severe mental health population is not included in program

Page: 2

Part 5: Facility Plan

- In regards to Phase II facility located in San Bernardino; will there be a facility in the High Desert? At this time, it will be located in San Bernardino dependent on vendors/contracts, the goal would be to have facilities in each region
 - Smaller Counties that do not have facilities, are teaming up to repurpose units in halls or camps; the Courts in these areas are putting off commitment orders until July

New Business

Discussion of Court Process for Future Cases

- Courts are working on an internal process and flow chart for staff- possible inclusion into Plan
- Legislation SB92 is the clean-up language for SB823
 - o Includes language for an Individual Rehabilitation Plan
 - Includes language for the Judicial Council to develop a Matrix of Offense-Based Classifications by July 1, 2023
 - Section 12; 875 Courts may add/reduce commitment time at the 6 month hearing
- Future Court hearing sets Eric Raley and/or Carl Landry will be made available to Court to explain program
- Discussion of youth commitments to DJJ and request for youth to remain in San Bernardino

Roundtable

Raley -

- Request for Information received; variety of classes and programs based in San Bernardino; not many based in High Desert
- Request for Information
 - Suggestion by Romero to request if services are offered in other regions, or if vendors are willing to travel to other areas
 - Inquiry for Outcome Measures
 - o RFP will be sent out within the next 60 days
- As of July 1st there are enough services/programs to begin through October
 - Courage to Change, Forward Thinking Journaling, Anger Replacement Treatment (ART) as well as others not listed
 - o Therapy Dog Program will begin August
 - O Department of Behavioral Health also has several classes/programs for use; once funding for positions have been secured, a list of programming will be created

Francis -

- Facility Updates
 - o Facility currently undergoing painting
 - Waiting for installation of flooring
 - o Furniture for living units has been delivered
 - Received part of the bedding and décor, along with upgraded linens
 - o Indoor/Outdoor Exercise Equipment has been ordered

- May 18th Board of Supervisors Hearing Probation CIP for facility improvement, landscaping and camera system, as well as DBH request for staffing positions
- A presentation of the Draft Plan will be presented to the Board of Supervisors either June 8th or June 22nd
- Facility Tour in June, dependent on flooring installation and furniture

Duckworth -

- Discussion of youth and roommates
 - Single Room as incentive for youth
 - o Roommates may be useful for youth to engage in conversations with
 - o Once the number of youth committed to program is given, further discussions can be had

Public Comments

Sandy Bonilla -

- Will the Committee be looking for services that Probation staff can't or won't provide?
 - Yes. Goal is to include Community Based Organizations for service
- Will the Committee also look for services from CBOs that Probation staff are trained in?
 - o Yes.
- Will the Committee ask for the CBOs experience in working with youth when the RFP is submitted?
 - o Yes

Jasmine Marchbanks -

- Is there a correlation between the youth entering the program and funding?
 - Language in SB92 discusses funding to the local level which will not be impacted for the next three years; there is no incentive to have more youth in program
- What plans are in place for undocumented youth and trans-gender youth?
 - Upon release, Probation does not disclose immigration status and will work with youth and youth's family to provide transitional housing and employment
 - Public Defender's Office employs an Immigration Lawyer to assist with obtaining legal status, along with Social Workers who assist as well
 - o Per Cannady in her years of service, she has not known of a trans-youth placed in DJJ
 - Social Workers along with Community Based Organizations will be utilized to address any trans-youth needs
- With the number of programs facilitated while in-custody, how will youth with mental health needs be released to mental health programs?
 - o DBH will oversee the mental health needs while in-custody; committee will continue to work on programming for Phase II when youth transitions from secured facility
 - There are a number of factors to review to best connect youth with community; private insurance, location of release
 - Appropriate providers will be established with an RFP; DBH already have providers in place through various treatment plans
- Is the Committee willing to work with CBOs for mental health services?
 - o Yes

- SB823 indicates three Community Based Organizations are to be on the Committee; is there a process for other organizations to get involved beyond public comment?
 - At this point of the process, additional CBOs will not be placed on the Committee, but are welcome to participate
- Riverside County has pushed back the Final Draft of the Plan due to the State to January 2022, why is San Bernardino trying to have it completed by June 2021?
 - Per Chief Deputy Public Defender Cannady, it is in the best interest of her clients to have them served in the community; there is little faith in DJJs services to youth and this committee is working for the best interest of the youth
 - o Final Draft will be posted online
- How can feedback and comments be given to the group from the public? If Final Draft of the Plan is posted, how can feedback be given?
 - o Information can be provided to Lisa Bari
 - The Plan must be submitted annually to the State; at that time the public will be able to provide feedback for revisions
- Cannady asked if Ms. Marchbanks' organization was able to respond to the Request For Information that Probation submitted?
 - o Not in San Bernardino; she was unaware of any of her colleagues were aware
 - Per Ms. Bonilla Over two months ago, Assembly Member Reyes held a community
 meeting informing participants of the local program and if anyone was interested in
 involvement to contact the Probation Department; she herself has mentioned the program to
 several CBOs in the community and has also provided information from the Committee back
 to the CBOs
- Terrance Stone asked if Riverside County had information posted for public viewing of information?
 - o Yes. But did not have the website available for distribution at this time
