Probation Update

 PCSII Gina Martinez, a member of the Gateway to ARISE program passed away; Thank you to FAST staff with assisting youth

CFS Update

- Jeany Zepeda has been appointed Public Health Assistant Director
- Cathleen Farrar will be joining committee as CFS representative

Court Update

- A. Romero to follow-up with Courts and Judicial Council:
 - What language the Court will use when transferring youth from secured treatment track to community housing
 - PER BSCC Rep, language used by Courts may affect how step-down facility would work

• Will the move from the step-down facility into housing in community be a separate order? Or will the order into Phase II be sufficient?

Program Update

- Currently housing 12 youth in program; working well
- College aged youth are all currently enrolled in online community college classes; looking for more hands-on courses

Victor Valley College Vocational Program

- Delay in services due to County RFP process
- Able to obtain approval from County for a one year contract; RFP will be submitted prior to end of contract
- Vocational Services should be in place by end of November
- DDII Raley has been collecting tools and inventory; Classes will be set up in two specialized rooms
- Vocational training to include, but not limited to: electrical, solar panel, alternate energy, construction, framing of houses and drywall
 - o These classes are being offered due to youth survey conducted several months ago

RFP

- DDII Raley and staff are working to resubmit RFP within the next 30 days
 - Added services for Step-Down program
 - o Emphasis on case management and job placement
- Due to technical difficulties with last RFP, staff will make an effort to reach out to as many vendors/providers as possible; staff will try to verify submissions were received
- A second RFP will be submitted with a focus on housing
 - Initially step-down housing option will be based in San Bernardino, however, goal is to provide housing and services in the areas youth came from
 - Services being requested will also include, but not limited to, gang and drug intervention, transgender services, restorative justice, vocational education, mental health services and sex offender services
- Once RFP is completed, Lisa Bari will send an email to committee
- Probation will send out RFP via various social media platforms
- Encourage vendors/providers to submit

Discussion of Phase II

- Tentative date to begin housing youth in step-down program is December
 - o By July 2022, DJJ youth may be released to step-down program by Courts
- October 5th, Probation staff met with BSCC representative, Craigus Thompson, to view the former Gateway facilities in San Bernardino and discus any necessary modification needed in compliance with Title 15 and Title 24
 - o Facility will need to transition from a locked facility
- Facility consists of three living areas which will be named East Cottage, West Cottage and North Cottage

- o Multipurpose Room
- o Perimeter will house Dorm Rooms college feel, rather than hall
- o Ability to house up to 20 youth per Cottage
- Outside fruit trees, basketball court
- o Kitchen will be upgraded and accessible to youth at all times
- O Youth will be living with Probation, but making their own schedule
- One building has bathrooms off of each room
- Ability to have female unit
- Youth will have access to participate in college sports and clubs once in step-down phase
