	Mireya Macias announced the retirement of Chief Brown as of March 12, 2021. Newly appointed Chief, Tracy Reece, will be present at our next scheduled meeting on April 27, 2021.		
Financial Report	Thomas Kamara indicated the budget report emailed in advance to the group for review was an overview of the budget with some anticipate minor changes that could occur prior to the submission deadline to the Board of Supervisors. Changes may include cost of living increase of 3 to 5 percent. The budget also reflects the absence of funding received from the School Districts, which is approximately \$700,000. This was a result of the JJCC Committee voted to not bill the school districts for the 25% of the School PO salary contribution for the upcoming fiscal year. Kamara reported no new positions have been added.		
	Scott Wyatt asked if the one-time funding for the School PO's was specifically for the 21/22 fiscal budget or future fiscal year budgets.		
	Thomas Kamara indicated this issue would need to be voted on an annual basis. The approval of the proposed budget is for the 2021/2022 fiscal year. The budget is an estimate and not the final numbers.		
	Mireya Macias reminded the committee the budget reflected the JJCC vote that occurred in January to not bill the School District's for the 25% of School PO salary and benefits. It was further noted a new School PO position was requested for the Fontana School District pending approval from the School Board.
