Homeless Outreach:

The department is having a Homeless Outreach Saturday, September 11, 2021. It's being held for adults, but under JJCC funds the youth population ages 13 to 23 years old are eligible for some services. A welding van

will be at San Bernardino DRC, they will provide a welding certificate and can connect adults with employment.

Juvenile Service Bureau Community Services Program:

Juvenile Service Bureau Community Services Program was established in October 2020. The department directly places youths currently on probation into this program, they organize learning service projects. A handout of the Juvenile Service Bureau Community Service Program brief was given to the committee with additional information regarding the services provided and indicating the community partners. The program is initiating additional community projects, projects will coincide with monthly events. The youth counselors at the Day Reporting Center will plan the event, provide the speakers and advertise events to local high schools for parents and kids. It will be either arranged to be at a high schools or at the DRC.
