#### **Probation Update**

#### Dana Smith-Lacy:

- Current population is 67, 3 females and 64 males.
- Programming is a hot topic, our Program Manager is here to discuss the programs being implemented at ARISE.
- Our state plan was accepted without any modifications.

#### Khara Garnett-Todd:

- 13 youth recently graduated from High School. A graduation ceremony was held and the families were in attendance.
- In talks with CBO's for more programming.
- Our goal is still to rehabilitate youth.
- 1 youth graduated from college who received his associate in business administration from Victor Valley College. A graduation ceremony was held, and the family was in attendance.

#### Marshe Marshall:

• I want to talk about programs being offered outside of the community-based organizations, we have several of our Probation Officers that have skill sets beyond the Probation Department that are willing to come in and teach our youth. They are being taught sewing by hand and work with

patterns and sew by machine, beanie making to provide to the homeless, Beast Mode, which is high intensity work outs, craft cards that involve using a Cricut to send to people in the military hospitals, chess club, cooking, gardening, pickleball, basketball and book club.

• We also have our mental health component that offers matrix, seeking safety and process groups for individual and family therapy.

#### Shawn Arrington:

- Our goal is for SOAR to be open before the year ends. The plan is for the youth to be there 6 months to a year. Staff will work with youth at ARISE before they transition to SOAR to ensure a seamless process. The goal is for youth to completely acclimate to their community.
- Construction moved to September.
- We are working on an intermediate plan for youth who don't quite meet the need for ARISE or don't
  qualify for placement. We recently had our contract approved with Pine Grove and California
  Conservation Corp. We are looking at all options.

#### Shonna Rossler:

- Our new process is a work in progress and we're making good traction by making sure we have enough programming.
- A big part is making sure we are being impartial and fair with all CBO's across the board and providing structure and consistency in the process. Expectations on both sides are clear.

Dana Smith-Lacy – we look forward to working with CBO's, they offer continuity and consistency.

Sandy Bonilla – Going to beta test the training on Positive Youth Development. It is an online training with 5 modules. It is free testing and would like honest feedback.
